**Over 50% of funds national parties got in '17-18 came from 'unknown' sources: ADR**

New Delhi, January 23

**OVER 50% OF** the funds national parties received during the financial year 2017-18 came from "unknown" sources that included donations through electoral bonds and voluntary contributions, according to election watchdog Association for Democratic Reforms (ADR).

The ADR on Wednesday released the findings of an analysis of six national parties' IT returns and donation statements filed with the Election Commission.

According to it, the total income of the BJP, the Congress, the CPI, the BSP, the TMC, and the NCP in 2017-18 was ₹1,293.05 crore.

The income of these parties from "unknown" sources was ₹689.44 crore, which is 53% of their total income.

The BJP alone declared ₹553.38 crore as its income from unknown sources, which is 80% of the total income of the national parties from such sources.

Out of ₹689.44 crore, the share from electoral bonds was ₹215 crore or 31%, the report said.

The parties received ₹354.22 crore or more than 51% of the fund from unknown sources through voluntary contributions (below ₹20,000), it said, adding the total income from other miscellaneous unknown sources was ₹4.5 crore. Also, 35% of their income or ₹467.13 crore from "known" donors.
