विनिर्माण विकास ने भारत के हालिया आर्थिक प्रदर्शन को आधार मुहँया कराया है, जो क्षेत्र के जिस निर्यातकों के लिए अतिरिक्त मांग बढ़ाने में मदद कर सकता है। वैश्विक वेरोजगारी दर और सार अल्पकालिक तौर पर उच्च बने रह सकते हैं क्योंकि वैश्विक श्रम बल में लगातार बढ़ोतारी हो रही है। विशेषकर वैश्विक बेरोजगारी दर में 2016 के 5.7 प्रतिशत की तुलना में 2017 में 5.8 प्रतिशत की मामूली वढत की संभावना है।

आईएलओं के महानिदेशक गाइ राइडर ने कहा, ''इस बक्त हमलोग वैश्विक अर्थव्यवस्था के कारण उत्पन्न क्षति एवं सामाजिक संकट में सुधार लाने और हर साल श्रम बाजार में आने वाले लाखों नवआगंतुकों के लिए गुणवत्तापूर्ण नौकरियों के निर्माण की दोहरी चुनौती का सामना कर रहे हैं। आईएलओ के वरिष्ठ अर्थशास्त्री और रिपोर्ट के मुख्य लेखक स्टीवेन टॉबिन ने कहा, "उभरते देशों में हर दो श्रमिकों में से एक जबिक विकासशील देशों में हर पांच में से चार श्रमिकों को रोजगार की बेहतर स्थितियों की आवश्यकता है।

इस आंकड़े में दक्षिण एशिया एवं उप सहारा अफ़ीका में और अधिक गिरावट आने का खतरा है। इसके अलाबा, विकसित देशों में बेरोजगारी में भी गिराबट आने की संभावना है और यह दर 2016 के 6.3 प्रतिशत से घटकर 6.2 प्रतिशत तक हो जाने की संभावना है।
