सेबी ने ब्रोकरों से बाजार में कारोबार कर रहे 107 गैर-सूचीबद्ध कंपनियों पर लगाम लगाने को कहा

नयी दिल्ली। शेयर बाजारों में मौजूदा मुखौटा कंपनियों के खिलाफ कार्वाई तेज करते हुए बाजार



नियामक सेबी ने शेयर बाजारों तथा ब्रोकरों से 107 गैर-सूचीबद्ध इकाइयों के ब्योरे का सत्यापन करने और परिणाम असंतोषजनक पाये जाने पर उन पर पाबंदी लगाने को कहा है। सूची में ज्यादातर ऐसी इकाइयाँ हैं जो रीयल एस्टेट, ट्रेडिंग और वित्त संबंधी कारोबार में लगी हैं। इससे पहले, भारतीय प्रतिभूति एवं विनिमय बोर्ड (सेबी) ने पिछले सप्ताह शेयर बाजारों से 331 संदिग्ध मुखौटा कंपनियों के शेयरों के कारोबार में प्रतिबंध लगाने को कहा। नियामक को यह सूची सेबी के कानून और नियमन के मुताबिक उपयुक्त कार्वाई को लेकर कारपोरेट कार्य मंत्रालय से मिली है।

बंबई शेयर बाजार (बीएसई) ने एक परिपत्र में आज कहा कि नियामक ने सलाह दी है कि जिन लोगों ने भी सूची में शामिल 107 गैर-सूचीबद्ध कंपनियों में से किसी को ग्राहक के तौर पर अपने साथ जोड़ा है, उनकी तमाम जानकारी हासिल कर ले तथा उसकी पुष्टि कर लें। परिपत्र में कहा गया है, 'अगर ऐसे किसी ग्राहक से प्राप्त जानकारी संतोषजनक नहीं पायी जाती है, उनकी यूसीसी (विशिष्ट ग्राहक कोड) को एक्सचेंज द्वारा अस्थायी तौर पर समाप्त कर देना चाहिए और इस बारे में रिपोर्ट सेबी को दी जानी चाहिए।'

सन फार्मा, दस अन्य ने सेबी के साथ मामला निपटाया

नयी दिल्ली। सन फार्मास्युटिकल, इसके प्रबंध निदेशक दिलीप सांघवी, चेयरमैन इम्राइल मकोव व आठ अन्य ने भेदिया कारोबार नियमों के कथित उल्लंघन के मामले में बाजार नियामक सेबी की जांच को आज निपटा लिया। इन इकाइयों ने इस मामले व जांच में निपटान शुल्क के रूप में 18 लाख रुपये का भुगतान किया है। सेबी ने इस मामले के ब्योरा नहीं दिया है लेकिन यह सन फार्मा द्वारा रेनबैक्सी के अधिग्रहण से जुड़ा नजर आता है। - एजेसी
